

Terms & Conditions

These conditions of entry relate to the “**Mickey Thompson Model Car**” promotion organised by **Exclusive Tyre Distributors Pty Ltd, ABN 51 159 029 357**, 30 Gow Street, Moorooka, QLD, 4105, Phone 1800 681 298 (“Promoter”).

By entering the competition, participants shall be deemed to agree with these conditions of entry, and give their consent to receive marketing information that ETD considers of relevance.

1. Entry is open to Australian residents only, but excludes all employees and the immediate families of the Promoter, its related companies, and retailers.
2. To be eligible to win, participants must:
